**Notice-cum-Addendum to the Scheme Information Document (SID) and Key Information Memorandum (KIM) of the schemes of ICICI Prudential Mutual Fund where Systematic Investment Plan (SIP) facility is available (the Schemes)**

**Introduction of Additional frequencies under SIP facility:**

Notice is hereby given that in addition to the existing frequencies, daily, weekly and fortnightly frequencies shall be available under SIP facility for all plans/options/sub-options of the Schemes, with effect from February 1, 2019.

The SIP date under the new frequencies shall be as follows:

Frequency	Specified Dates
Daily Option	Daily (only Business days)
Weekly Option	Wednesday*
Fortnightly	1 <sup>st</sup> or 16 <sup>th</sup> day of each month, as applicable*

\* In the event that such a day is a non-business day, the application would be processed on the next business day.

Minimum number of installments for daily, weekly and fortnightly frequency will be 6. The minimum installment amount under the new frequencies shall be the same as minimum amount prescribed for SIP under monthly frequencies in the respective scheme.

Also, SIP Plus facility shall be available under the new frequencies. The minimum installment amount to avail SIP Plus facility under the new frequencies shall be the minimum amount prescribed for SIP (under respective frequencies) in the respective scheme, subject to minimum of ₹ 500/- per installment.

**This Notice-cum-addendum forms an integral part of the SID/KIM/addenda of the Schemes, as amended from time to time.**

**All other provisions of the SID/KIM/addenda of the Schemes except as specifically modified herein above remain unchanged.**
