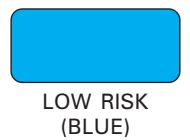



**NOTICE-CUM-ADDENDUM** is hereby given to all the investors of the Scheme, in terms of enabling provisions of Regulation 33(4) of SEBI (Mutual Funds) Regulations, 1996, for rolling over (extension of maturity date) of the Scheme.

Pursuant to provision to Regulation 33(4) of SEBI (Mutual Funds) Regulations, 1996, it is proposed to roll over (extend the maturity date) the Scheme to May 18, 2016. The existing maturity date is May 18, 2015. The details and material terms of such roll over (extension of maturity date) are as follows:

- Purpose** - The purpose of the roll over (extension of maturity date) is to continue to benefit from the prevailing yields in the fixed income market taking into consideration the current economic and regulatory environment.
- Period** - 366 days. Accordingly, the revised maturity date of the Scheme will be May 18, 2016.
- Extended Maturity Date** - May 18, 2016 (or immediately following business day if the maturity date falls on a non-business day.)
- Date of Roll over:** May 19, 2015 (or immediately following business day if the maturity date falls on a non-business day.)
- Terms of roll over** (extension of maturity date) - Upon roll over of the Scheme, certain provisions of the Scheme stand modified. The existing and modified provisions are stated below:
