  - (b) The signature of the unitholder needs to be attested from folio registered bank account. (bank attestation will be in original and will include account number, name of signatory, employee code, designation (branch Manager & above), bank Full seal and signature).
  - (c) Copy of photo identification (id) proof - PAN, Passport, Adhar card, Driving license etc. (self-attested by the investor).
- 2) Request for updation of new signature and attestation cannot be submitted from folio registered bank mandate, below given documents to be obtained:-
  - (a) Letter /Standalone form from the investor requesting updation of new signature. Request will include reason for not being able to submit attestation from folio registered bank mandate.
  - (b) Attestation from new bank of the investor or Affidavit on Rs 100/- stamp paper requesting for new signature with notary attestation.

*(Notary attestation will be in original and will include notary registration number with full address, seal and signature of the notary).*
